FACTS staff members are Mandatory Reporters under the Child Protective Services Law. [ADDED: The Mandatory reporting laws were changed in 2014 after the Sandusky events at Penn State. As a result, you are not required or expected to get permission from your supervisor prior to making a Child Abuse or Neglect report to Child Line. The adult who either witnessed the abuse, witnessed any concerning marks or behaviors or who the child directly reported the abuse to must be the person to make the report.] If a staff member suspects that a child is neglected or abused, they must immediately make an electronic report using the online PA Child Line system. After filing the Child Line Report, the employee must immediately report the suspected abuse to the Principal or the Director of School Culture. Students who come to school with marks on their bodies, who exhibit sudden marked changes in behavior, who are absent for long periods of time, or who exhibit precocious behaviors of a sexual nature must be immediately reported to the Principal.

Discussion:

- Is it necessary to include the historical background of the Sandusky events in this section of the employee handbook?
- The reason to include it is to make sure that staff understand the gravity of the responsibility to report and not to rely on supervisors to do the reporting.
