Pheng Lim

- Just finished with students last week. This is the last week for teachers
- How FACTS is addressing the Black Lives Matter movement and the police killing of George Floyd
 - Letter from the Principal
 - Principal, Directors of School Culture, and Social Worker held open conversations with students; parents were invited. Middle school teachers addressed the issue more directly in classes and morning meeting
 - It was important to hear parent voices; there was a necessary sharing of different perspectives.
 - As a school there is a lot more work to do to address racism and the other isms. Want to work on addressing racism more directly and specifically
 - Being remote, it is harder to provide emotional support for students, and this year we had ten new staff so we didn't feel that our whole staff was equipped to have these conversations with students.
 - Sent resources home about how to talk to children about these issues of racism and police violence
 - Want to work on getting more parent support
- Our 15th Play Day was held remotely. Teachers created 36 student challenges and live sessions. There were 1464 views of our Play Day playlist. Teachers went all out
- End of year celebrations had different themes: third grade camping celebration, fourth grade fancy party, 6th grade DJ party. Different grades were very different but all felt great.
- 8th Grade Promotion Ceremony: The most impactful moments were students sharing advice and memories. We will be holding a Promotion Drive through celebration; or for those unable to make it, we are driving their certificates and t-shirts to their homes.
- We are surveying parents and teachers about their virtual learning experiences, using surveys to improve what we are doing
