Working hard on planning the re-opening

 Shared updates of our plans with staff: using data to guide us, we are leaning towards the hybrid model or full virtual depending on how the pandemic is impacting Philadelphia

A parent meeting will be held on July 20, with different zoom meetings in different language groups
Summer Programs have started

Discussion:

- Will FACTS be offered an all online option?
 - o SDP is not offering 100% remote in the individual school buildings, but will offer a centralized online academy with a curriculum that isn't necessarily tied to their own school's curriculum. Parents need to commit to a full quarter and then can choose to transition back to their school.
 - o FACTS is researching live streaming technology options.
- In the hybrid model, what will instruction look like?
 - o Probably will be a combination of synchronous and asynchronous teaching and learning.
- What is FACTS doing about immuno-compromised staff?

- Staff concerns were raised following the staff meeting: Admin is crafting responses to staff. We need to balance being responsive to staff concerns with our need to focus our work.
- Will windowless rooms be used?
- Has there been consideration of having younger students in school and older students more remote?
 - o The math of it doesn't work. We have too many younger students to create reduced density with that model.

Debriefing the Strategic Planning Session

A goal was to create connections between board members and staff. How did people feel?

- Break out sessions allowed time to interact with staff and get to know people and learn their perspectives and concerns.
- Felt affirmed by where we are as a group in our mission and the kind of community we want to build. This is important in this time as we're faced with such big challenges.
- First time meeting staff and teachers. Discussions were all over the place: from social issues to how to do online learning. We need to do more focused follow-ups on specific topics. e.g. one on social justice, another on online learning, etc. because all need time for in-depth discussion.
- Nice to hear directly from staff. Would have wanted to have mixed up the groups to hear from a variety of staff members. Found the notetaking process confusing because the questions were overlapping. Hard to write on one Googledoc at the same time.

- Got to see my child' teacher, and it was good to hear her perspective. The time went so quickly. Appreciated people's commitment to FACTS to meet for three hours on a Saturday.
- Best thing was talking to staff. Found them bright and thoughtful and the board was also humanized. Some questions could have been sharpened a bit. The challenge of wanting to create room for new insights while keeping the conversation moving forward.
- Well organized and facilitated. Got to meet staff members. We are facing the pandemic of our lives, but staff's spirits were there. They were engaged and it was energizing.
- Appreciated getting to know a newer staff member. Successful in connecting people.
- Repetitiveness of the questions: because the staff is so present with the
 mission, the intent was to have the second half push deeply into what the
 mission calls us to do in this moment. It turned out that the discussion went
 there very quickly in the first half of the meeting.
- I hope that we can use this tool of Zoom to keep parents more connected to the school.

Next Steps: Steering Committee will review the notes and plan a second gathering to generate more concrete steps.

- Seven days in
- Attendance has been 96-98% daily
- BTSN: next week: split into two nights K-4; and 5-8
- Packet Pick-ups will be next week: All families are required to come by FACTS to pick up workbooks, and other resources for learning
- Minor incidents of Zoom crashers last week
 - Passcodes were changed and we are transitioning to accessing Zoom sessions via Google Calendar
- DRA (Developmental Reading Assessment) is going on. This will give us a
 baseline assessment for all students. We are anticipating that there will be a
 learning loss from the school closure.
- Universal Screeners in math are being given next week
- Enrollment: we have ten slots to fill
- We had a Kindergarten drive through and virtual meet and greet
- Thank you to Neeta, T. Vince, T. Ray, and six teacher tech leaders who are helping FACTS transition to Google Suites and Google Classroom
- Some positive feedback from students on Google Classroom. Some students reported having more confidence and calm about navigating getting to class
- Third grade classroom: what is something that is going well; "the night before school I was filled with joy and almost cried, looking forward to school."
- It is hard for younger students, K-3. Teachers are enthusiastic and creative, but remote learning is hard for the youngest students especially.

Discussion of the first week and a half of school: attendance, high points, challenges. Parents' view:

- First grader is struggling; fourth grader has been more successful.
- Tech Pick up went really smoothly; set up was simple and easy to get up and running. First grade child is accessing instruction at her day care.
 Reported for the first time feeling sleepy during one class. Got a prize for sticking to it all day long.
- First grader and a fourth grader. Harder for the younger child. Very hard. Mistakenly went to the wrong class today.
- First grader and fourth grader. Fourth grader was taught to use email and had his first chance to connect with his friends, so he started sending emails to his friends in breaks between classes. Nice that the teacher opened up the possibility for students to connect with their friends.

- There are unforeseen issues introduced by the program such as overcrowding of our middle school

- Parents on the Board would like to initiate a Board convened parent group that would focus on racial equity at home (not focused on what's happening at school): resources, conversation, tools for parenting with a focus on racial equity. Would fill some needs in the FACTS community. Parent engagement could be an area for growth for FACTS. This would be a committee connected through the Board more than through the staff.
 - Discussion: What initiatives has the school made? What have the past efforts been?
 - School was founded out of racial equity perspective and many school practices reflect that. That's a baseline of where our school stands and where our mission is grounded.
 - In May, FACTS invited parents to participate in discussions of racial justice issues. Found that there was not shared language or shared values, but families sharing stories and their own experiences helped students and families gain understanding and hear different perspectives
 - This is what has attracted some families to FACTS
 - Majority Asian school uniquely positions FACTS. There is so much diversity within the Asian American community (ethnically, generationally, etc.)
- The idea of neighborhood or online meet ups that allow children in small groups to interact in a playful way
 - Question of how to be inclusive
- Opportunities for parents to engage/connect with each other?

- Mini-Grant from Jounce: getting support with how to make virtual lesson plans virtually and use all adults in supporting student learning
- Pheng was featured in an article in the Philadelphia Inquirer about the challenges of remote teaching and learning
- Have gathered baseline data for math and reading in order to identify student who are struggling academically and need small group support
- Started using Talking Points to communicate with parents, a way to communicate with parents with quick translation through text messaging
- Next week is the second round of distribution of supplies and packets (including physical books) collecting packets which can be used for assessment
- Why we're having high rates of attendance and participation is the quality of relationships built with students and the level of trust we've built with students and parents

Discussion:

Does the school plan more school wide assemblies? Was the MPOV

IV. Revision of the 2020-21 Budget

Presentation David Brown

At the time of the passage of the budget last spring, we did not yet know the per pupil allocation or the impact of the Covid pandemic on the school's finances. In the revised budget, income was adjusted for things that had to be cancelled such as the 5K, and expenses for cancelled events like field trips were reduced. The bottom line is not very different from the original budget. We are still expecting to run a surplus. For the five year projection, we are budgeting for a flat per pupil rate because we don't know the impact of the pandemic and the economic downturn on school funding.

Discussion:

- A school in New Jersey reported that they were able to use Medicaid reimbursements to pay for school meals. Is that possible for us?
- The food program is currently serving fewer than half of the students formerly participating.
- Will Covid related grant funds cover all of our Covid related expenses or a majority of it?
 - Some of the expenses not covered will be online subscriptions.
 Many of the Covid related expenses will be covered by the grant funding.
 - Two instructional supports were covered by the grant. In addition to facilities changes and Covid related supplies, we were able to support two teaching staff to provide additional supports to students who are struggling.
 - The fiscal cliff is still looming. The PA Coalition of Public Charter Schools received a \$30 million fund for charter expansions. Is there any thought of trying to seek funding from this source?
 - Are we fully enrolled now? The Stars program is smaller.

The Policy Committee met to discuss reopening criteria, parameters and timelines. The discussion is captured in the report.

Discussion and Questions:

WHAT DO PARENT SURVEY DATA REVEAL?

- Parent comments on the survey were helpful but didn't point to a direction about reopening
- There is a big difference in the response to staying fully remote versus sending students to school between Chinese language responses and English-speaking responses.
 - One factor may be the large number of intergenerational households and also family members' roles in caretaking
 - Families don't want to cut off connections to older generations.
 Grandparent visits no longer able to happen. Mental health concerns for the elder generation
 - Many Chinese people think that others don't take science seriously enough

 Part of the response may be to the choice being only returning one day a week, so parents have to decide whether to break their bubble or their return for one day a week.

WHAT ELSE ARE WE LEARNING ABOUT COVID SPREAD?

- Do we have data about charter schools in Philadelphia that have in person instruction?
- Information seems to be coming out that schools have not been major causes of spreading Covid
- Looking at the metrics, we see them shifting and it's hard to see how they will stabilize
- Contrasting the PDE criteria and the summer metrics we used.

SENSE OF URGENCY TO GETTING STUDENTS BACK INTO THE BUILDING

- Deeply concerned about K-2 students. Don't feel good about education through Zoom for the little ones. It is incumbent on us, when it is safe for students and adults to get the little ones in school. There is higher level of success for accessing learning remotely for older students.
- There will not be a clear end to the pandemic. It will be a slower improvement. We need to focus on what's best for students. We should start the runway as soon as we can
- Concern that Covid set back could impact students for years to come.

WHAT DO WE NEED TO KNOW IN ORDER TO MAKE THE DECISION TO RETURN TO SCHOOL?

- Policy Committee: we need to be considering whether our families would come back, how our staff feel, and whether our school building is ready
- Any decision to open quickly should be impacted by how online learning is going.
- Want to look at more data before greenlighting something. At the same time there is a feeling of urgency
- The more data the better: how online schooling is going. How it's going for staff. If we could have another month to look at the data.
- Assessment of student learning is hard right now. How to assess whether K-2 students are learning as they should.
 - Specifically interested in how ELD and SPED students are doing
 - There is a huge number of ELD students in K
- Next week we will receive packets back from students so we can better assess how remote learning is going.
- Need more info on how online learning is going. We need to know more about how students are engaging online in order to decide on bringing students back. Can't decide right now.

FACTS PROPOSED MODEL OF HYBRID LEARNING

- The design we have is that the one day a week focuses on supporting students social and emotional well-being, providing supports for remote learning, helping to set them up for success in online learning.
- The content teaching is housed on Mondays, Tuesdays and Fridays; students will not miss out on the academic content whether they choose in person or 100% remote. What students crave most is the socialization and mental health, we are addressing that need in our hybrid model. For

- parents who are opting out, perhaps there are ways to support socializing virtually.
- It's positive that parents can make choices to go fully remote.
- We need to find ways to keep the school feeling like a community, with many students staying fully remote and others opting to go in to school.
- Even returning, we need to temper our expectations of what in-person school looks like in the pandemic; school will not feel like it did before. (distancing, masks, etc.)
- At what point does it not make sense to convene a class? Is there a threshold below which it doesn't make sense to convene certain classes/grades?
- Not all parents need to be on board with a plan to bring students back to the building since they can opt for 100% remote.

POSSIBLE SCENARIOS FOR REOPENING

- We should seek to open in January. We should continue to monitor the Covid conditions and safety conditions.
 - Notice to parents: we intend to open in January; will you send your student in person?
 - At November meeting, we could reevaluate the status of the pandemic. We don't use today's statistics to move forward with January opening.
- Restarting in January could be the worst time. If families are traveling, then they may be infected during travel and relaxed vigilance during the holidays. Two weeks after the holidays is when cases may be showing up.
 - If families are traveling, we want them to quarantine for fourteen days.
 - We don't want families to extend their travel since they don't have to return by January 4 with remote learning.
- Admin estimates that it will take about two months between the time we
 decide on a reopening date and executing on that reopening (we're calling
 this the "on ramp"). Even if we start right now, we believe that mid to late
 January is the earliest we would be ready to reopen the building due to
 holiday breaks.
 - On Ramp includes: school's communication to parents and staff of our intentions; response/commitment forms from staff and parents; based on staff and parent commitment forms we need to regroup students into new cohorts depending on who is opting to stay 100% remote; develop staffing plan; creating schedules for in school and remote learning; training, planning logistics, practicing new Covid safety measures; teacher prep time for new in school model; teacher room set up time
- We want to communicate as soon as possible with parents, but realize that they will be making plans based on these communications which may be shifting. If we tell parents we're aiming for a January start, then parents and staff are setting up their lives around this idea. If we are thinking it's a 90% chance it's one thing, but if we think it's closer to 50/50 then it could be creating a burden on parents and staff families to have them prepare for something that probably won't happen.
- We should take into consideration family preferences. That should also be a factor.

 When we do bring students back, we probably need to do K-8. We may want to prioritize K-2, but for families to make it work, we may need to bring back K-8

DECISIONS:

- We will not decide about a schedule for reopening until the November meeting. We will not call a Special Meeting to make a call.
- There will be an adhoc board/admin committee for planning reopening. The committee will synthesize more info, frame up questions
 - If the data in November points to it, try to open in late January.
 - Pull five teachers together to get some qualitative data
- There will be a two-part process: first a go ahead with a planned date for reopening, and then a green light (last decision to move forward)
- Communicate that we will be in full virtual until the end of 2020. The Board will be making further decisions about returning to the building at its November meeting (between now and December) but they will not take effect until 2021.

V. Discussion of School Reopening

The Ad Hoc Committee met. Since that time, conditions in the Philadelphia area have shifted considerably, for the worse.

Information and Perspectives Gathered

Student Achievement and Attendance Data

Pheng Lim

Discussion:

- Attendance Data: Number of students who have missed two or more days per month is a more useful piece of data than % attending. This is a good working definition of problematic attendance.
- What kind of intervention is planned for those students who are regressing?

- FACTS is offering targeted support through small group instruction. "What I Need" Sessions are happening three days per week. Different approaches including building relationships, social/emotional support, as well as academic supports.
- FACTS is also emphasizing accountability. We are basing grades on the data that we have, for example, for students who are not submitting work. This is also teaching a necessary life skill of accountability.
- Is there a big difference between conducting the DRAs in person versus remotely? Is there something we need to be adjusting with the next round of testing?
 - We are still learning. An example is one student being tested who could not be heard. Also distractions when students are in a daycare or Access Center. We are not sure how to address this problem; we are learning as we go. Also, students are getting more used to using online forms.

Teacher Perspectives

Tim Matheney

- Board members met with seven K-3 teachers, including general ed as well as ELD, SPED, and interventionists and also got some feedback from an online survey.
- Key Themes:

Positives:

- Effectiveness of using small groups. able to connect with students and monitor students more closely
- Even virtually it's been possible to build community. Morning Meetings have worked fairly well. Students are still excited about seeing their teachers and each other. Many were excited about a red shirt day
- Progress Monitoring: Virtual world has forced us to be more deliberate and this has led to stronger efforts at systematic monitoring of progress

Challenges:

- Teaching writing is hard but teachers are trying different approaches.
- Individual tech issues, also environment challenges. Imagine the challenges of explaining to an English Learner about how to use Zoom remotely.
- Students who were vulnerable before March are more vulnerable today. This is also reinforced through the data, e.g. in one class, none of the 14 on level students are EL or SPED. And teachers are mindful of that.
- The schedule. The schedule when you're all virtual and trying to stay ambitious is challenging. Pheng told the group that she is thinking of possibilities of tweaking the schedule.

Summary:

- What Tim has heard from FACTS is consistent to what he's hearing from others.
- Impressed by teachers. The conversation could have gone negative, but it was a positive conversation. Staff did not

- hold back on challenges but were solutions-oriented. We have a lot of work to do; we will be in virtual learning for the foreseeable future.
- Teachers were concerned about the consistency of the schedule (different schedules on different days of the week).
- Social skills concerns: students online have been exhibiting less control and less maturity. There will likely be a need to rebuild social skills when we return to the school building.
 - That is developmentally appropriate given the stress students are under.
- Encouraging to hear of the supports that students have gotten from their caregivers.
- Impressive participation in Family Literacy Night.

Parent Perspectives

Parents Present

- Every day it gets better. Fourth grader is excited about writing and published her first piece. First grader is maturing, every day is getting better. It feels like school. Pleased with what my children are getting in virtual learning
- First grader has a positive attitude. At the beginning it was rocky. Parent was more stressed than the student. The student is more comfortable now and is able to navigate to classes. Making progress in reading and writing. Four days a week at a daycare. Has connected with their teacher and is excited to see her.
- Don't know much about what is going on with the fourth grader. She
 has made a lot of Flipgrid stories. Loves writing and is producing a
 lot of little books. First grader is loving reading and is reading a lot.
 He is sneaking in reading when he is not supposed to be reading.
 Enjoying school more than expected. The long days seem too long.
- My kids are happy at school. Had an issue with my child watching Youtube during class. Parts of their personalities are coming out. I can see them growing. For both students, emotions are big; when something small goes wrong, it brings on tears.

Discussion: Perspectives on Returning to the Building

- Knowing what we know now, if the building were ready, we might have opened in September and would be shutting down now. We should be preparing now to bring students in during whatever windows are possible for bringing students back. If things improve dramatically in the spring, we should be prepared to go back using our hybrid model. We should not give up on the idea of going to the building.
- It was hard at the beginning of the year, but now things are getting into a rhythm. If I were told now I had to go back to work, it would be challenging. It is a transition for staff and students and families to get into a new routine. If the spread of Covid remains severe and we aren't talking about returning to the school until the spring,we should look at if it's worth the disruption to return to the building if we only have x weeks left.

- We heard from some of the teachers that they want to shift the schedule around. Wanting longer class periods, with content. The centerpiece of the current schedule is to create space to be present with each other; it was not created to maximize 100% remote learning. We may be spending the year holding space for the ideal of being in person in exchange for being able to deliver a more excellent online curriculum. If we are going to be online for the remainder of the year, what is the best way to do this for teachers and students?
- We have to think of both scenarios; either bringing back students for in person learning but also figure out how to build robust online learning. My bias is that students learn best face to face with their teachers. Want to hold this as what we strive for, especially in the youngest grades.
- I come at this personally: five colleagues have contracted covid, one is on life support. This is a real threat. In-person learning is best for children, but we need to balance safety and academics.
- Has the school looked at the ventilation system?
 - If we don't know if masks on inside would provide protection if there isn't enough air flow.
 - Only a third of the SDP schools have adequate airflow.
 - What does define a safe space for people to be in?
- Would the Board consider returning to school while Philadelphia County is at a substantial level of community spread (using the PDE and DOH measure)?

Communication:

- The world may change a lot in the next several months. We have to watch
 the data carefully. It is important to bring students back. We need to
 communicate to parents, to plan for virtual learning until at least January
 19 or whichever date we decide on.
- We want to aim for clear concise communication with as much advance notice as possible. It will create stress if going back and forth between announcements that we're opening/not opening.
- Communication is also important with students. We should have open communication with students.

Agreement and Next Steps

- 1. Admin will continue to work quickly and diligently to prepare for reopening the building.
- 2. Communicate the following to staff and parents:

"The City of Philadelphia has now moved into the category of 'substantial level of community transmission of Covid-19' for the third straight week.

The FACTS Board of Trustees has decided that FACTS will remain 100% remote until at least February 16, 2021. We urge FACTS community members to be cautious in their holiday travels and holiday gatherings.

FACTS will send more information about a future opening date in early January. We will review a variety of metrics provided by City and state education and health authorities and will also consider school readiness before making a decision on reopening. Please remember that, as a

charter school, FACTS makes its own decisions and is not governed by decisions of the School District of Philadelphia.

When we do return to the school for in-person teaching and learning, we will be using the FACTS hybrid plan, with students learning remotely 4 days per week and coming into school one day per week (either a Wednesday or a Thursday). All families will have the option to remain 100% online"

- Chronic Absenteeism: We have had 87 students who have been absent.
 Chronic absenteeism is defined as missing three or more days without an excuse. Attendance team has been working with families to see what supports can help increase attendance. Seven students are on our list of chronic absences. We are hovering at around a 97% attendance rate.
- A Holocaust survivor visited sixth grade social studies classes.
- Celebration of Peace is 12/17 at 2:15. It will include the dismantling of the sand mandala this year.
- Continuing with the bookfair. It helps generate funds for the purchase of books for classroom libraries.
- Principal is attending a National Institute of School Leaders training. A lot
 of the practices we are doing at FACTS are being discussed as model
 practices such as teacher portfolios with inquiry learning.
- Innovageous is consulting on tech needs of teachers and working with teachers most in need of support.
- Parent Teacher conferences are next week. Coming out of the virtual environment, there are some positives such as remote conferences that make it easier for many parents to participate. We may continue some of these practices.
- Response to Intervention is making good progress. The virtual environment is pushing FACTS to strengthen our data culture. We are forming a data team.
- Special Education team: we are working on staff being conscious of using inclusive of language regarding special education and disabilities.
- Math team is using formative assessments more and better in the virtual context.

- Intent to Return forms are coming back. Two teachers are considering retiring, one teacher wants to reduce hours and responsibilities, one teacher is not returning.
- A letter went out to families to inform them of the choices of books for Read Alouds for grades K-3 (e.g. LGBT, anti-bullying, anti-racism, etc).

The Audit Committee (Neeta and Tim) read the whole audit and met with the auditor. The committee's recommendation is to accept the audit. Note that the large liability for PSERS is part of general accounting standards and not a reason to be alarmed. There is no management letter which is a testament to the Finance Director's work. The unaudited financial statements that we approved in June were largely, with a few small adjustments, the same as the audit. No issues were raised in terms of financial controls. The materials circulated on the board's role in the audit were helpful. There are essentially three audits in one (school, LEA, single audit of federal funds).

Discussion:

How is our relationship with the auditor going?

- The same firm has been doing our audit for many years, but there are different members of the team who take the lead.
 The auditor was helpful in answering questions and thorough in going through the notes and talking through the audit.
- FACTS has had a long relationship with Joyce Miller & Associates. We switched away from her firm one year and then came back because it was not a good experience. Most CPA firms do not have deep experience with charter school finances.
- It is good that within the firm, the team switches. The team was very proficient.
- David interviewed a second auditor and found that they had all worked with Joyce Miller and learned what they know from that experience.

VII. Emergency Paid Sick Leave Policy

Proposed Emergency Paid Sick Leave Policy:

From January 1, 2021 until March 31, 2021 or until the Families First Coronavirus Response Act (FFCRA) or its equivalent is reinstated, FACTS will offer staff an Emergency Paid Sick Leave bank of 10 emergency paid sick leave days to be administered as an extension of the expired federal program. This bank of emergency paid sick leave will be available for staff who are subject to leave for the following reasons:

- Being subject to a federal, state, or local quarantine or isolation order related to COVID–19 and there is no remote work available:
- Being advised by a health care provider to self-quarantine due to concerns related to COVID–19 and there is no remote work available:
- Experiencing symptoms of COVID-19 and seeking a medical diagnosis;
- Experiencing possible symptoms of COVID–19 per the school's self-screener policy and therefore being directed to stay home;
- Caring for an individual who has been ordered or advised to quarantine by a government agency or health care provider; or
- Caring for a child whose school or place of care is closed, or whose child care provider is unavailable, due to COVID-19 precautions.

If FACTS directs an employee to quarantine or self-isolate at home due to an exposure or possible exposure to Covid-19 at the school, the employee will continue to be paid and will not be asked to use sick leave or personal or

vacation days for that period of time. Employees will be expected to work from home to the extent possible. This policy applies to part time staff as well as to full time staff. Compensation to part time staff will be based on their regular hours of work.

This Emergency Sick leave bank will be used before an employee's regular paid sick leave. Unused Emergency sick leave will not be rolled over to the next school year. It does not accumulate. For part time employees, Emergency Paid Sick Leave days will be prorated based on the number of hours worked during their regular schedule. Staff who have already used paid sick leave from the FFCRA would not be eligible for leave under this policy that exceeds a total 10 days of Emergency Paid Sick leave (or the part time equivalent).

Employees experiencing longer periods of illness have access to FACTS's Short Term Disability Insurance which can take effect after 8 days of sick leave. Employees who contract Covid-19 while at FACTS are eligible for Workers Compensation coverage

Discussion:

- What has the usage of emergency paid sick leave been to date?
 - Seven employees have been asked to self isolate from three different exposure events.
- Do we have a plan for substitutes?
 - The sub services we have been using have not made themselves available. We have some in house subs.
 - We have been moving staff around to cover for staff who are absent.
- For a future discussion, how would the availability of a vaccine or the ability of teachers to access vaccination change our thoughts on reopening to students?
 - People are hearing different things about the availability and there are many policies and other complicated issues involved; we will have much more information on this in a month or two. More conversation can happen then.
 - Even if every teacher is vaccinated, we still need to have the conversation with parents and students.
 - o Children under 16 cannot get vaccinated.
 - As vaccinations proceed, presumably community spread will be reduced. A lot of the concern has been about risk to adults.
- Right now, we are using the assumption that as long as Philadelphia is at a substantial level of transmission, we will not be bringing students back to the school.
- It's good that this is a limited term policy so that we will revisit this in March. So many things are shifting and it will be good to evaluate again in March.
- The financial liability would be limited during this trial period of the policy.

- Sharing a video excerpt from the Celebration of Peace
- Training for Principals: Pheng shared that FACTS strengthens and maintains community through music. For example the FACTS play list of songs that inspire our staff and sharing that music at staff meetings. FACTS is attempting to find connections to students and between staff members
- DRAs, our reading diagnostic: We are in the second round of testing and will be finished with testing all of the students next week. We are seeing that students are learning, but we are trying to understand the pace of learning and don't have a comparison to past years.
- We are analyzing report cards and looking at who is meeting grade level standards.
- Deadline for applying to FACTS is February 5: Our Intent to Enroll numbers are lower than usual. We now have 207 applications.
- Lunar New Year Celebration is February 11
- High School Admissions: 51 of 57 8th graders were admitted to one of their choice schools. 20 were accepted to Carver, which is high for us. We are now working to find placements for the remaining students. Charter School applications are happening now. It is a stressful situation for 8th graders.
- WIDA ACCESS Testing: a mandatory standardized test for English Learners. This year families are allowed to opt out. FACTS sent letters to families explaining what the test is, what other methods of assessment we use, and asking if parents want their students to participate.

Discussion:

- Is attendance holding steady?
 - Yes, attendance is still holding steady at around 96% or 97%. We are looking for ways to support students and families struggling with attendance. We still have a small number of students who are chronically absent and are trying to work with their families.

III. Stars Program

Ellen Somekawa

- Does our charter require that we maintain the program or maintain a certain size of enrollment? [no]
- The process of intake and screening English Learners at the School District changed right as we started our program, so this source of referrals did not come through for us.
- Social workers could be a source of recruitment and referrals
- Are there any current lottery applications that would qualify for the program? [no]
- If we need to put the program on pause, we want to make it clear how much we value the program
- We want to express appreciation to Teacher Lucinda for the incredible work in setting up the program and to say that you have the support of the Board; it is important to our mission
- Emphasize that this is a temporary pause.

Proposal: Establish a board and staff committee to steward the Stars Program. The committee will explore: What we learned from the Stars program, how we use that knowledge as a jumping off point for when we are able to restart the program, how we can create conditions for re-starting the program and recognize when conditions are ripe. The committee will plan to meet once before the end of the school year, and do some evaluation while the program is still operating so we can gather data and information.

FACTS is in good shape. Flagging some issues: Our income projections are down due to a reduction in enrollment (partly due to lower Stars enrollment and also due to some vacancies not filled in the upper grades). We will be slightly under enrolled in future years. We are expected to receive additional funding from federal COVID Relief that can help see us through potential budget shortfalls. We know that lean times are coming, but have good sized reserves. Admin is working on the budget for next year. The financials for November are

included in the December Financial Statements so we did not present them separately. We will need to approve our Form 990 in the next two months.

Discussion:

- Why did the number of Special Education students go up?
 - We tested the kindergarten students. Our goal is to get the testing done by December, but because of remote learning, we couldn't get the evaluations done in time. Proposal from Admin is to set a date of April 14 for reopening in our hybrid model which is far enough into the future that Admin can begin making concrete plans for the reopening starting now and the pandemic conditions may have shifted by then.

Discussion

Responses to the Proposed Opening Date of April 14:

- Don't object to the date. It seems a little soon given that we don't know what will happen with the vaccine.
- Is the building ready? Want to know more about air circulation and ventilation. This is an important factor in spread.
- Nervous about the thought of reopening. If given the option of returning to my own work in a school, I would choose not to. It makes me anxious.
- Thinking about coming back right after spring break. Might people travel and might we see a spike? We could inform parents that if they travel, they should quarantine for ten days.
 - April 14 is ten days after Spring Break
- We need to take the time to create a concrete plan that is predictable. It's hard when you're in a stressful situation to ask people to change. Don't want people to feel that they are being bounced around. Going back into the building and resetting will be a huge change and challenge for students, staff, families. We're asking people to learn how to do something in a new way. There is a lot of conflicting information about learning loss and about what is safe. We won't know the lasting effects of this for decades.
- Every time we talk about this, we talk about the same things. We are not in better shape in terms of what is known. We aren't going to have the answers to these questions maybe for years. We are going to have to take some risks. We have this date in mind; I suggest that if all the adults in the building have had the opportunity to have the vaccine by this date, then we will open. The vaccine is more of the game changer in terms of having teachers back in the building. The vaccine's timing is an uncertainty. If that is not the case, we may delay. And also a change in community spread would be expected. If that is not the case, then we are in another set of problems.

Clarifications About the Hybrid Model

- Our plan is for K-8 to return to the building?
 - Yes.
- Clarification on our hybrid model. Our model is for the in person days on Weds and Thursday being focused on Social and Emotional Learning and well being, community building, exploration; MTF focus on academic content taught remotely. Want to talk about what learning means. Invite us to discuss if there are things being gained that we do not measure.
- Teachers and I believe that there can't be different teachers teaching in person and remote at the same time. That would sacrifice the quality of instruction. Principal does not want to move to that model.
 - Agreed
 - Agreed

- Checking to make sure that if and when we return in a hybrid, families have the option to continue 100% remote.
 - Yes
- If half of students do not want to return, do we have the ability to keep teachers fully remote or do we have all teachers come back? Is it all hands on deck?
 - We will need responses from parents in order to plan.

School and Building Preparedness

- I'm looking at new guidance on the new strains of COVID-19 going around and now the guidance is to wear two masks. Given that families and children will lose masks or not come with masks'
 - We have 500 children's masks and will buy more if we run out or are close to running out.
- Have we thought through what do we do if we get a positive case? Do we inform parents of any positive cases?
 - This information is contained in the Return to School Guide for Parents. The link to the guide is being sent to the Board.

Urgency of Return to the Building: Learning Loss

- I would approach this with a lot of gravity. We would be looking at students learning virtually for another 30% of the year. Extending virtual learning for that much more of the year is sobering.
- Shared a link to a Mckinsey report that shows COVID learning loss. Even if students are learning, but they are not learning at the same rate as usual, we need to get students back in person. We know that poverty-impacted students lose many months of learning in virtual settings, so that weighs heavily on me. We should get back to in-person learning as soon as conditions permit. We are not there yet. But when the level of community spread reaches a particular level, schools should consider opening. I am fearful that we will experience more learning loss if we continue fully remote for 30% more of the year. April 14 seems pretty far off. We have many examples of schools being open with minimal cases. The timeline of ten days after spring break seems too long. If we postpone until mid-April, we should consider more than one day per week, especially for younger students. I am uncomfortable with the proposal.

There is More Than One Way to Think About Learning Loss:

- We need a discussion of what counts as learning when we talk about learning loss. Want to think more broadly about what students are learning or losing.
- Don't know that it's helpful to weigh learning loss versus health risks. Not as useful to compare what is happening now to what was in the past. Can't define learning or attendance as in the past. Whatever amount of learning we choose to measure this year is not a forecast to what happens to students in the future.

- How do we think about learning loss? How do we engage in this conversation within the ethic of care prioritizing certain definitions of learning, maybe deemphasize standardization in learning loss.

Changes in COVID Conditions and Knowledge:

- The science is still evolving with the new variant and transmissibility. What
 would the decision rules be for when we would open and when we would
 close again. What information we are able to provide to parents.
- In the US it is taken as an accepted fact that schools aren't the cause of community spread whereas in other countries this is not taken as a proven fact and that perhaps schools are a cause of community spread. From Kenzo: Evidence from Canada that schools contribute to the spread: https://montrealgazette.com/news/local-news/emsb-unveils-air-purifiers-maintaining-they-will-slow-spread-of-covid-19
- Also vaccines also do not necessarily protect against getting the disease, but reduce the severity of the disease. People still may get the disease and being able to pass on
- Agree that we have to make decisions about both health concerns and learning concerns. My concern is about making decisions about 30% of the school year. There are many variables involving the vaccine schedule and the rate of covid spread. Uncomfortable making the decision now about a long period of time before a return to school. Think we would have more information in a couple of weeks.
- The information we have will be changing, whether we make a decision now or in a few weeks. It is a certainty that the information will be changing. We can't wait for certainty in order to make a decision. Want us to decide and not remain without making a decision until June.
- From Tim: Another interesting article: https://www.usnews.com/news/education-news/articles/2020-12-23/new-st udy-cautiously-suggests-schools-dont-increase-spread-of-coronavirus (The proviso is that Philly, despite signs of good trends, still has high community spread.)

Desire for More Input

- If at all possible, have a meeting to figure out what teachers and parents want to do. Share the proposal and have a vote to reopen rather than us deciding for them. Teachers should have a voice.
- Important points but feel pressed to figure out what decisions to make tonight. We told parents that the earliest we would plan to open is February 16. Whatever we decide, we need to be clear with them. Can we decide what our communication is to parents?
- When was the last time staff were asked of their comfort level? Parents have the option to choose. It is the staff who don't have the option.
- Part of my job is to send plants to families who have members who have died, and I'm sending so many plants. We do need to say something to families and staff.
- Originally I said I wouldn't send my kids back. I know I'm able more than most to support my kids with learning loss. My kids are begging to go

back. I know the decision is so hard. Thank you for listening so hard to each other. I don't know if my answer would be the same the next time.

- Could we survey staff?
 - What would a survey say? Almost anyone would want to stay home if given a chance.
 - One of the conversations would be about the vaccine. Once you are vaccinated, would you be willing to come back? There will be a range of responses.
 - If teachers aren't willing to come back after being vaccinated at what point will they be willing to come back?
 - I don't want to do a survey if it isn't going to be real. We need to know what we will do with the information if we ask a question.
 - o Some teachers are willing to work extra days in person.
 - Surveys are empowering

Setting Contingencies along with Date to Return

- In terms of timeline, there are contingencies with setting a set date, there still must be some contingencies. Part of the decision could be based on staff having the opportunity to be vaccinated, but this is a moving target and the roll out is going badly so far.
- We should establish a date for reopening along with criteria for reopening, and make a final determination if this criteria has been met by the March 17 board meeting. Between now and then we come up with criteria of what would need to be true if we are to reopen.
- The Ad Hoc Committee on School Reopening to discuss next steps.

Review of FACTS: K messageData Presentation [slideshow]

Discussion:

- Critical question is how the report card data compares to previous years, if we want to understand the impact of remote learning.
- What accounts for the cohorts who are more behind?
- How are these skills such as "Listening" assessed in a virtual environment; could that have skewed the data? [We removed Listening from the third marking period]
- Noticed in K-4 data is the significant gap between who is meeting grade level standards in literacy and math. Much higher percentages of students on grade level in math than literacy. Was that also true pre-COVID?
 - Math in lower grades where the skills are more computational are doing better in a remote environment. In the upper grades, students report having a harder time learning math in the remote environment.
- Thank you for the thoughtfulness and for taking the time to ask the students how they are doing and feeling and for following through with students who report having a hard time.

- Many students reported liking the Small Learning Community and Explore Classes and we are looking at how we can continue those practices when we return to in-person learning.
- Can school leadership reflect on the significant decline in the percentage of students on grade level (as determined by DRAs)?
 - We are putting more resources into a cohort that is not showing growth this year. More teacher coaching, more small group intervention.
 - We put more resources into phonics instruction by changing to a new program, but this was interrupted by school closure and we did not have even a full year of implementing the program.
 - We departmentalize starting in the early grades; this year we experimented with one teacher focusing only on literacy and the other homeroom teacher teaching math as well as social studies and science.
 - FACTS is investing more time in early literacy.
- The overall DRA data showed something like 79% of students making progress. That means that 1 in 5 students are not making progress. There is much to celebrate, but that is a sobering number.
 - Appreciation to the Literacy Coordinator for pushing forward with the DRAs in the remote environment because it allows us to track student progress.
 - We need to explore what our annual summer learning loss is year to year.
- Is it possible that students who are reading above grade level are not showing up as making progress?

VII. **School Reopening Discussion**

School Data that may inform the reopening decision

Discussion:

- What would experience of students whose families are electing to remain 100% remotely?
 - There schedule would remain much the same as it is currently, but they would likely be taught be different teachers.
- Does this call on teachers to be simultaneously teaching both to students in person and remotely?
 - No
- Do you have an idea of what percentage of families will elect the hybrid in-person?
 - No; but approximately half said they would elect 100% remote in a survey in the fall.
- Do people have a chance to change their mind if they find themselves uncomfortable with their choice?
 - A parent may alway elect to move their child from in-person to 100% remote, but it is not so easy to move a student from all remote to in-person.
 - We do not have that many remaining weeks of school, so we don't want parents changing back and forth between in person and remote. We are asking parents to commit to a decision.

Presentation on New CDC Guidelines:

- We feel bolstered that the new CDC guidelines align with the approach we have taken with reopening. They have presented five criteria for a safe reopening; four are totally do-able for us, and the fifth involves support from the City Health Department, but FACTS as a small community can do contact tracing.
- We have been talking about a threshold of community spread since last July. We have been using a metric averaged over seven days. The CDC guidelines use a total over seven days. Therefore our metric of 10 daily new cases or fewer per 100,000 (based on a seven day average) maps onto the CDC metric as 70 new cases total over a seven day period. Today Philadelphia is 161 cases per 100,000 which puts us in the red category. Our original proposed resolution was at 70 new cases per 100,000.

Discussion:

- Is there a reason we're not going to 99 which is the CDC guideline (orange zone)? Should we change ours to 50-99? The new CDC guideline suggests that even in red, elementary but not middle schools could be open in a hybrid model. I suggest the metric be 99 or fewer.
- The other piece that our school is missing is expanded testing. If rapid testing is not available and if we are not randomly testing students, suggest reopening is still open in the orange zone.
- There could be an amendment to change the metric for community spread to 99
- Amendment: changing from OR to AND because community spread should always be a consideration about reopening regardless of other mitigation strategies.

- Oppose this because what we are doing is so limited for this year. Disappointed that we are only going to have students go back one day a week. There are delays in the vaccinations. If community spread is low, then we would be taking off the option of reopening for the rest of the year if not every single teacher gets both doses of vaccine.
- If we use the OR, we could have a situation where we open in red and many teachers are not vaccinated but have had the opportunity to be vaccinated.
- Amendment: want to have clarity about conditions for the need to close.
 - If adults in the building are all vaccinated, then does the rate of community spread going up a little bit warrant shutting down the whole school?
 - The experience of schools that are open is that they close based on cases or clusters in the school itself and not on community spread.
 Once we are open, we would recommend to not close based on fluctuations in community spread.
 - Concern about the chaos involved in moving back and forth between in person and 100% remote.
- Amendment: want to have clarity about when and how conditions are met.
- We're talking about what is our acceptable risk. How many student deaths are we okay with? What are we okay with?
 - If we're talking about the conditions under which we close, then are we being preventative or reactive? If we use community spread, then we're being preventative. As we see the numbers go up then we close down as opposed to waiting until people are already sick. Everyone will have to vote with their conscience.
- It makes sense to put forward a board resolution about reopening, but would advise not to put forward a board resolution about moving back to fully remote and instead rely on decision makers at that time.
- I am conducting a research study talking to Asst Superintendents and Superintendents and charter leaders across the country and am struck by how many have figured this out. Their students are in school, learning content and people are not getting sick. Kids, especially in the early grades, learn better in person. Many many schools including in Philadelphia are open and kids are in school multiple days a week. One school leader reported that 83% of their students are in hybrid learning. Philosophically I cannot support the idea of even one day a week in person. Others are doing more than we are proposing to do. It's a matter of conscience and I can't support this direction. Other outcomes could have occurred.
- I am committed to getting students into the building as many days as we can but recognize that the direction has been the one day a week hybrid. It is inflammatory to be talking about how many dead students are acceptable. That is not what is happening across the country. School opening has been shown to be pretty safe with precautions put in place. But we need to look at what are the risks of not being in school. My child is doing fine academically, but she hates school and is upset a lot. People have not been in a bubble the whole year, but the one risk we are not willing to take is one so important to children. Other schools have been open hybrid or even five days a week. I am frankly looking at other school

- options because I can't do this another year. COVID is going to happen to some of our families regardless of whether we open in person or not.
- There are strongly held different opinions even in large cities like NYC, and often these break down along lines of class and race. There is also an undercurrent about blaming the teachers for student mental health issues, without looking at all of the factors contributing to community mental health concerns.
- If we choose the AND, and not everybody has had the chance to be vaccinated are we saying we wouldn't be willing to push the reopening date back one week?
 - At a certain point it isn't worth the heavy lift, if it will be so few days of students being in school.
- Intention of the resolution was to give Admin the information they need to act. To get our doors open in the fall takes a whole summer of preparation. To open our doors at any time takes a great deal of work. The effort is to channel, not to curtail discussion.

VIII. Discussion of the Stars Program

Please see the ED report for information on new information impacting our Stars Program.

Discussion

 We shared our decision about putting the Stars program on pause. Our partner at HIAS shared that the refugee resettlement agencies are gearing up for a significant increase in refugees coming to Philadelphia. There is a pipeline of people whose cases were stalled which is now moving. Other

- refugee resettlement agencies are restructuring and gearing up their programs.
- This seems like the time to introduce ourselves as partners, as resettlement agencies are getting their new systems set up. We have struggled to partner with some of the agencies before, but now they are convening as a group, so we have a chance to build relationships with these other organizations who may be able to refer students to us. We want to be known as reliable partners to these organizations and to be ready to receive students who may be coming.
- Would we consider keeping the program going so that we can be positioned to partner with these groups now?
- For long term planning, this may be a strategic choice as we look towards expansion. In terms of mission as well as growth.
- We were saddened to put the program on hiatus. At this point in time, we decided not to enroll students in 6-8 grades. If we are able to build back the Stars program, we have slots in the middle school now.
- We still have a problem with where Stars go when they exit the program (more quickly than we originally planned). This needs to be figured out. If the majority of students we are getting are refugees, many come with limited schooling, limited literacy in their first language and gaps in school skills. The chances of them exiting in one year are relatively low.
- If there is a big number or percentage of refugees, how will this impact our counselor's work?
 - Those who are coming as refugees often have caseworkers and other supports.
 - We have been thinking about universal designing for Trauma Informed Practices, to implement practices that support students with all that they are bringing.
- By next month, we might have more of an estimate of numbers of refugees expected to be arriving in the summer and fall.

Next Steps

 We will present the draft budget to the board next month and think that will be a time for the Board to deliberate over whether to take the program off of pause.

VII. Discussion of the PSSAs

 - Individuals can reach out to people in public positions to make noise about this. The board can start an email chain with draft messages for board members to share and a google group.

 - We should think about responding to the advocacy groups that pushed for the testing not to be waived.
 - Are we writing as a school board, as public officials? Where are the lines?

- Crossing the line would be advocating for our parents to opt out. We should focus our message on disapproval of the administration of the tests during the pandemic.
- One idea we have is to optimize the morning times for students' experience. We will start off students' days with community building and instruction and schedule the tests for the afternoons.

- Results of the Parent Commitment Form and Staff Reopening Survey
- Currently the plan is to look at metrics for community spread as of next week. The metrics have been up and down. At of now, the metrics would point to not reopening
- All teachers will have had the chance to be vaccinated by CHOP.
- It is important that revisiting this discussion not disrupt our relationships of trust with the staff. Families would have a chance to opt out.

Does the Board agree to reopening this discussion again?

Discussion:

- With the number of families opting for remote, do we have a staffing model that can handle that remote learning? [yes]
- After we talk about the spring, we should do another survey to plan for the fall to find out what the families feel comfortable about.
- I would see reopening in the Spring as a good stepping stone. Families get the choice, and staff have had a chance to be vaccinated. It sounds like we would have a manageable number of students returning.
- Looking at just nine days max of any child opting in, today there was an elementary school that only brought back second graders and closed already. What consideration could be made for disruptions to families' plan caused by unexpected closures?
- What new information has emerged to lead to our revisiting this discussion?
 - All teachers have had a chance to be vaccinated.
 - Survey results of teachers:
 - Many teachers agree with the idea of going back but at the same time have mixed feelings about returning.
 - Part of mixed feelings is that it is only one day a week and no additional academic material being presented.
 - Part of mixed feelings also is not opposition to coming back but natural anxieties and a mix of excitement and worry.
 - 50% of our families want their students to come back. There were also students who reported not doing okay in all remote.
- Reminder of what in-person school will be like: Morning Meeting, two outdoor times, one journaling/reflection period, one read out loud, one math fluency practice, one period of qigong, one IDR. There will be learning happening all day.

- At the last meeting, we talked about how community spread impacts our decision. We had expected that community spread would go down. But this month it hasn't dropped below 110. The spread is still there.
- How to prepare for the fall is a legitimate concern. Is there any other way to prepare for the fall besides reopening?
 - If we had to do a full reopening of all 485 students, it would be hard to prepare.
 - We want teachers to have the chance to ease into teaching a smaller group of students instead of going from all remote to full capacity. We may increase teacher comfort levels with a soft reopening this spring.
 - Politicians may be painting a rosy picture, It could be a very different world we're living in September 1.
- Last meeting was draining. Can we just vote?
- Why is the SDP only opening K-2?
 - Only a third of the classrooms passed the ventilation studies, so they had to start small to rectify the issues before expanding to more classrooms.
 - Teachers Union must approve the use of specific spaces.
- Every fall, educators go through the feeling of having to enter with new classes. It's always an adjustment.
- **3. V. Presentation of the Draft 2021-22 Budget

Presentation of the Draft Budget

David Brown

This is a draft budget for discussion purposes. The Board will need to approve the 2021-22 budget at the May or June meeting. We need to submit our budget to the state by June 30.

Bottom Line: In 2021-22 we are budgeting for a surplus. Often what drives our surplus is that we don't know what the per pupil allocation from the SDP will be; we base our budget on a guess. But for the past few years, the per pupil allocation has been going up more than the 1% that we budget for. Our cash reserve is now healthy with about 4 months of operating expenses. Our draft budget assumes that the per pupil allocation from the SDP will remain flat (assuming hard times coming up). In 2023-24, our projections show us starting to go into the red.

Budget Process: David and Ellen meet to talk about the big picture. David talks with Pheng about instructional needs, meets with the departments and gathers all of the needs from the departments so the budget is in tune with where we want to go educationally. We start by putting in the wish lists, and then prioritize.

Questions and concerns from the Board

- What was the per pupil this year for SPED and regular ed? Is there additional allocation for Stars students?
 - There is no additional funding to support the needs of ELD students with the exception of a small Title III allocation which doesn't even cover our costs of translation.
 - FACTS and AAU have at times advocated on this issue. There were increases in the new state funding formula, however this funding formula only applies to new funding, so the vast majority of state funding is not guided by this or any other funding formula. And although the funding formula directed increased funding to districts with a large number of students in poverty and ELD students, the funding formula does not make the funding follow the students. This means that the School District may receive more funding due to its high percentage of ELD students, but this does not mean that the SDP allocates increased funding to schools serving a higher number of ELD students.
- Does the budget include funding for students whose needs we can't meet at FACTS, who may need an Alternate Private School Placement?
 - Every student of our is our responsibility, but if FACTS cannot meet the needs of the student because they may benefit from a more therapeutic setting, then we may need to place them in a private school setting. Then we pay their tuition.
 - Yes, we budget for two students in APS. This is the most that have been in APS at any one time
- Local funding: What is the cause of the big drop in funding?
 - Local funding could include school fundraisers like the 5K, but also grant funding. We didn't get the Math Grant this year.
- Why is salary decreasing between 2021-22 and 2022-23?
 - Will look into it.
 - Why are benefits going up while salary is going down?
- How math grant funding impacts program planning for next year:
 - A lot of questions about summer programs, after school programs, etc. will be part of the discussion of ESSER III.
- We will have the opportunity to amend the budget when we get new information such as our per pupil allocation. We typically approve a budget in May or June and find out what the per pupil allocation is after that. In the fall we may revise the budget and have the board approve it in the fall.
- Curious about the folk arts program.
 - We have to evaluate the modality of teaching folk arts; how has it been going virtually.
 - The ensembles program is challenging because it brings together students from different grades and clusters
- We are 130% over on IT budget; are these one time expenses? How will we budget for the future?

- Introduction of technology into the school is new and has been covered by COVID relief grants.
- Admin will get a report on CB damage and replacement costs. We don't even have a year of experience. For the next three years this will be covered by stimulus grants, but we have to figure out how we will stand on our own.
- More than the devices, it's the cost of bigger IT staffing, upgrading infrastructure, subscriptions, and increased security needs

VI. Stars Program

In light of the Draft Budget just presented, does the Board want to reconsider the decision to put the Stars Program on pause?

- We had talked about revisiting our decision to put a pause on the Stars program
- Possibilities of changes to the refugee program
- How many students do we need to break even?
 - o 10 to 12
- Recruitment? Are programs like Migrant Ed referring to us?
 - We have made outreach efforts but other than HIAS, organizations have been making referrals to us. This includes community groups like Migrant Ed, other refugee organizations, and other charter schools, all of whom we reached out to.
- This is hiring season
- Partly budget risk and also mission
 - We didn't fill all of our vacant slots in 6,7,8. Stars students would fill in those grades.

III. Discussion of the Changing Role of Technology

Selina Morales

This discussion will be the beginning stage of developing a vision for technology at FACTS. We want the Board to offer mission-guided and strategic vision to a new technology plan. This is a beginning conversation to help guide work that is starting this summer.

What excites you about bringing more tech into the school?

- Using GoogleClassroom, parents can now see what is being asked of students: know what they are doing in school.
- Global connections, being able to have conversations with anyone anywhere in the world. Creating human connections with people in different places.
- Different opportunities for different kids to learn in different ways and unleash their creativity. Tech can be a tool in that.
- Tech is the future. Now it is the new norm and people are needing to know how to use it to function.
- Connecting tech to elevating student voices.
- Concerned about online safety and want kids to learn this at school. More parent to school relationship about tech safety.
- Having every family with a laptop, parent-teacher conferences were so much easier for everyone to participate in. Hard for working families to participate in in-person meetings, especially if you can't bring your kids.
- Acquiring new skills aligned to standards. Can find a healthy balance of not relying too much on tech, but using it as a tool. Not using tech as a replacement.
- Student centered learning that can take place live in a classroom.
 Targeted instruction to student needs.

- Ability to broaden the community beyond the school perimeters. Other kids and communities could take part.
- Additional resources as ways for teachers to engage students and support families. Ability to create equitable access not only to devices but how to engage with families.
- Tech is the main way that children are exchanging folk arts among themselves.

What concerns you about bringing more tech into the school?

- How quickly screens can make children forget how to be human in the world
- This is a whole new realm of expense to the school. Without a plan to pay for it, we can't afford it. Need to live within our means. Once stimulus funding stops, what do we cut to pay for tech? We will love it, incorporate it into our curriculum and then the funding will go away.
- Having more access to tech is a way for students to learn more about safety skills in navigating the internet, but there is not the same support at home for security and safety.
- Training teachers and supporting teachers to use tech. Some people (generationally often) struggle more with tech. Tech is always upgrading. If you training one time but then do not keep more training with all of the upgrades, the organization moves onto the next shiny thing.
- Some people don't like change. If there is an agreement to move to tech, then we need to get everyone onboard.
- Kids will have access to tech so we need to be proactive in the safe use of tech.
- Uneven access: some kids needed more help but weren't able to get help from parents. Some kids will get a lot of help and other kids won't get any help, increasing the divide between students.
- Increasing anything in the curriculum results in a decrease in something else. Worry about maintaining the centrality of folk arts, social justice, community.
- Feel lucky children at FACTS don't get an education that is fashionable, but one that focuses on appreciating one another. Getting into habits of speaking directly to folks, human interaction is a priority in our curriculum in a world that is pushing away from that.
- The practice of folk arts in communities is shifting a lot, not clear where this is headed, and technology is playing a big role in this.
- Student and teacher training on digital citizenship. Internet bullying, the permanence of what is posted on the internet. People need to be trained on the dangers of internet behavior
- Sharing of folk arts is a platform but that is different from creating and experiencing folk arts. It's a question of finding the balance. Don't want the sharing to replace the making, creating, experiencing of folk arts.
- Digital divide with kids' home situations and differential access to help from parents. If students get "coded" as a bad student online [see Ruha Benjamin's Race After Technology, 2019]
- How new technology is to the profession of teaching. As a teacher I don't understand how to integrate technology into my teaching effectively. Need for Professional Development opportunities so teachers don't have to learn it on their own. It's a gradual process to learn how to make this effective for students. Training must be part of this project

- Tech can be a tool but it can be a cudgel or a crutch. It is potentially addictive.
- From a teaching end, I want to be focused on looking at tech as a tool (not always the best, sometime necessary). There can be a knee jerk desire for the next new thing.

Discussion:

- This technology is approaching being old. It is now tech that I have grown up with. It isn't something new for most students, but it is part of their world. We gave the same concerns over safety when students go outside, but we don't want to be fearful everytime the door is open. The internet is just like the mall and people you don't want your kid around. Then parents decide that kids shouldn't be there by themselves.
- What are some areas where we need to create guidance?
- We need to discuss the kind of expertise and conversation we need in order to develop guidance.

Next year's per pupil will be about equal to that reduced per pupil amount for 2020-21. It is expected that our per pupil will go down in future years. We anticipate that the School District will be using federal stimulus funding

to cover some normal existing or planned expenses that would have counted as expenses and that are part of the calculation of what charter schools receive. When the SDP pays for these expenses using stimulus funding, those expenses will now longer count in the calculation for per pupil allocations to charter schools. This is why we have a concern over our budget projections and also over how we will pay for increased technology expenses when federal funding goes away.

VII. Mask Policy

Does the Board wish to align our school's mask policy with the new City of Philadelphia guidance? Below is an Excerpt from the City of Philadelphia's press release.

"At 12:01 a.m., on Friday, June 11, 2021, the City of Philadelphia will end the last two COVID-19 restrictions: the indoor mask mandate and the 11:00 p.m. last call for restaurants. People who got their final dose of COVID vaccine at least two weeks ago are considered fully vaccinated, and the Health Department no longer requires that they wear masks indoors or outdoors in most settings. People who are not vaccinated or are not fully vaccinated are still strongly recommended to wear masks indoors and outdoors when around others but are no longer required to do so by Philadelphia. . .

"Lifting the requirement for vaccinated people to wear masks indoors doesn't mean that we are totally past COVID-19. Dozens of Philadelphians are still being diagnosed with COVID-19 every day, which means that more of us still need to get vaccinated."

"Due to ongoing risk, Philadelphia will still require that masks be worn indoors in select settings, including but not limited to . . . Indoor schools."
