The Folk Arts-Cultural Treasures Charter School (FACTS) is a Local Education Agency (LEA) that receives Title I funds and has chosen to implement a school-wide program using these funds that is designed to meet the educational needs of all students in the school.

What are Title I funds? Title I funds are federal government grant funds that provide financial assistance to local educational agencies (LEAs) and schools to improve the academic achievement of disadvantaged students. The Title I grant is made available to ensure that all children have a fair, equal, and significant opportunity to obtain a high-quality education and reach, at a minimum, proficiency on challenging state academic achievement standards and state academic assessments.

FACTS believes that the improved academic achievement of each student is a responsibility shared by the entire school community, including the Board of Trustees, school administration, staff, community members, students, and parents (defined for the purposes of this policy to include guardians and all members of a student's family involved in the student's education).

This **Parent and Family Engagement Policy** is being adopted in order to:

- 2. Provide coordination, technical assistance and other support necessary to assist in planning and implementing effective family engagement activities to improve academic achievement and school performance.

This policy shall serve as written documentation of FACTS commitment to ensure parents are welcomed, engaged, and valued stakeholders in the education of their children.

- Placing the finalized policy on the school's website (<u>www.factschool.org</u>) and the Parent Portal (<u>www.plusportals.com/factschool</u>). Hard copies will be available at the annual Title I meeting, Back to School Night and by request from the office throughout the year.
- FACTS will involve parents in the process of school review and improvement (ESSA, Section 1116(a)(2)(A)), by:
 - 0 Providing parents with limited English proficiency access to fully translated documents.
 - Utilizing bi-lingual staff, contracted interpreters, or telephone interpretation service for parents with limited English proficiency so they may fully participate in meetings
 - Providing adequate advance notice to parents of meetings through notices sent home, robo calls, email, and electronic parent portals.
- FACTS will provide technical assistance and support in planning and implementing effective parent and family engagement activities to improve student academic achievement and school performance (*ESSA*, *Section 1116(a)(2)(B)*), by:

- FACTS will conduct an annual survey to collect data and feedback on the content and effectiveness of the school level and LEA level parent and family engagement policies. Survey results will be used to:
 - Identify barriers to greater participation by parents and family members, with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background.
