#### Discussion:

- Question: Would like to learn the 5 or 6 things that often go wrong; or the 5 or 6 most important things. (Pitfalls to avoid and best practices)
  - Response: Will have a working session with the board early on; it is important to prioritize the top three competency areas. Will force the choice down to three. important to get board buy in. Cadence of biweekly meetings is important to get frequent feedback, surface concerns; keep the trains moving in the right direction. Want to avoid a lack of transparency with the community; hear as many voices as possible. Leadership searches can produce anxiety. This also provides FACTS with a snapshot of our community, what is important to people. Sets the new ED up for success. Edgility uses a search site that houses all of the materials related to the search
- Question: What is the role of Admin in the search process?
  - Response: ED is an outward facing role; you need a strong communicator; overseeing staff, operations, managing staff and layers of staff. Will be looking for charter school experience in community based charter schools. Admin members are part of the

discovery process; meet with direct reports. Some members are part of the search committee. Ask them to be part of the finalist round. Important to be responsive to you all. Have seen Admin teams throw things off.

- Question: What is your process for outreach and networks; how do you go about expanding your networks?
  - Have 40,000 applicants in the system. Some have gone far into the process. Will post in LinkedIn and other job boards. A cultivation person will do cultivation calls. Will ask for referrals and connectors
- Concern that Edgility says that we would be looking for experienced charter school leader. Not sure this is the case. Instead would prioritize understanding of mission. Want to know the preconceptions Edgility is starting with.
- What happens if we hit March and things are not where we need them to be?
- Want to base contract not on number of months but on completion of the search cycle.

## VIII. Approval of the Revised Budget [10 minutes]

We are required to submit our approved budget in June but don't learn of the next year's per pupil allocation until later. Information on the per pupil rate comes late so that we typically pass a revised budget the following fall. Income is up \$1M. Also a salary increase that was triggered by the rise in the per pupil rate led to an increase in expenses. The revised budget reflects the actual staffing, prices of health insurance, etc. A contingency line is included in the budget. Experts predict that the per pupil rate will level out and will not continue to have high increases as we have seen for the past few years.

#### **Discussion and Questions**

- If the per pupil allocations level out, will we still be in a good position for our expansion?
  - Yes. Projections for future years are based on a 3% increase in per pupil per year.

- Ellen worked with Building Hope and PIDC to apply for Redevelopment Assistance Capital Program (RACP) funding. The application is for \$5M in funding for building construction. It is a political process so will require gaining legislators' and the Governor's support.
